I, the undersigned, understand and acknowledge that play on an amusement/inflatable device entails both known and unknown risks including, but not limited to, physical injury from falling, slipping, bruising, crashing or colliding, emotional injury, paralysis, distress, damage to any participant. I hereby voluntarily and expressly release, indemnify, forever discharge and hold harmless Urtusastegui Holdings LLC dba Jeronimo!, its members, owners, managers, directors or any interest or shareholders from any and all liability, claims, demands, causes or rights of action whether personal to me or to a third party, which are in any way connected with participation in this activity, including those allegedly attributable to negligent acts or omissions. Should Urtusastegui Holdings LLC dba Jeronimo! or anyone acting on behalf of Urtusastegui Holdings LLC dba Jeronimo! be required to incur attorney's fees and cost to enforce this agreement, I expressly agree to indemnify and hold Urtusastegui Holdings LLC dba Jeronimo! harmless for all such fees and costs. In the event I, the undersigned, or any of my participants file a lawsuit against Urtusastegui Holdings LLC dba Jeronimo!, it is agreed to do so solely in the State of Georgia. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. I acknowledge that I have the capacity and authority to execute this contract, that I read the Jeronimo! rules, that I understand them, and that I have conveyed the rules to my child(ren) or to those for whom I act as guardian.

1. No teasing, tormenting, or torturing.
2. Wait until the child in front of you gets off the slide before you go.
3. No flips, wrestling, or horseplay.
4. Don't run because you may knock someone down and hurt them.
5. Socks only, and no sharp objects in your. Take off your jewelry, earrings, scarves, glasses, contacts, cell phones, iPods, and retainers, too. No gum, candy or drinks allowed in the inflatables area. Girls with hair past shoulder length: You will need to braid it or put it up so no one jumps on it.
6. Jump in the bouncy thing, not on the bouncy thing. Do not climb on the inflatables.
7. Jeronimo! is segregated by age. Children aged 2-4 play in one area; children aged 5+ play elsewhere. The age groups are not allowed to mingle.
8. Do not chew on the nets.
9. If the inflatables lose power, it will deflate slowly. Just get off calmly and quickly.
10. If you are pregnant, are susceptible to injury from falls bumps or bouncing, if you have head, neck, back or muscular-skeleton injuries or disabilities, please do not jump.
11. The owner or employees may ask you to leave if you do not follow the rules.
